KANSAS CITY MEETING

The University of Illinois Library School Alumni Association held its annual dinner meeting on June 16, 1938, at the Hotel Muehlebach in Kansas City during the 60th Annual American Library Association Conference. It was also the 40th year since the organization of our Association. There were 219 present. Following an entertaining program of music and dancing presented by local pertorners the meeting was called to order by the President, Wilma L. Shelton, who gave a brief address. Miss Frances Simpson, Assistant Director of the Library School emerita, was then welcomed by the President, and responded with a few words of greeting to the members of the Association. The report of the Secretary Treasurer, Miss Houchens, was read and approved. A letter of greeting from Mr. Windsor was read by the President. Miss Ethel Bond read a letter from Miss Amelia Krieg describing the general prospects for placement of graduates of the School. Miss Bond also announced that Felix E. Snider of Fremont Missouri, had been awarded the Sharp Memorial Scholarship for 1938-1939. Mr. Arnold Trotier gave a report on the Adah Patton Memorial Fund. The financial report of the Trustees of the Endowment Fund, submitted by Mr. John S. Cleavinger, was read by the acting secretary. The report of the Committee appointed to consider the proposed celebration of the 40th anniversary of the Library School was read by the acting secretary in the absence of Mis Nelle Signor, chairman. The Committee agreed that the celebration should be deferred until 1943 with the prospect of holding a combined celebration with Armour Institute of Technology, which will celebrate its 50th anniversary at that time. The University of Illinois also will be celebrating its 75th anniversary in the same year. The Committee recommended that a permanent committee of five members be appointed to meet together in Kansas City to formulate plans for the celebration. The President announced that since there was still considerable time in which to consider the matter, the appointment of the committee had been left to the incoming president.

Upon motion by Everett O. Fontaine, the secretary was instructed to send to the family of Miss Mary Eileen Ahern the deep regrets of her fellow alumn upon her recent death. Miss Simpson announced that flowers had been sent for Miss Ahern's funeral by members of the faculty and staff of the University

Library and Library School.

It was moved by Ida Wright that the greetings of the assembled alumni be sent to Mr. and Mrs. Windsor and Miss Krieg. Mary J. Booth moved that a letter be sent to Miss Margaret Mann, recently retired as Associate Professor of Library Science at the University of Michigan Library School, expressing our appreciation of her service to the profession.

The Nominating Committee composed of Ethel Bond, Della Sissler, and Rudolph Gjelsness, Chairman, proposed the following officers for 1938-39: President, Alice Coldren; 1st Vice-president, Flora Eckert; 2nd Vice-president, Nelle Branch; Secretary-Treasurer, Josie B. Houchens; Trustee of the Endowment Fund, John S. Cleavinger. All were unanimously elected.

The Association is indebted to the local committee for a delightful dinner and program.

The attention of the Association is called to the need for increasing the annual membership list. South eastern is the Oklahoma Teachers' College and offers the service of a travelling library to the residents of its district. More than 3,000 books are contained in the unit which sends out books for a month's period.

Phyllis Crawford won the \$3,000 prize awarded annually by the Julia Ellsworth Ford Foundation in a contest for children's books with "Hello

the Boat," a book published this fall by Henry Holt & Co.

Her book is the story of storeboat life on the Ohio river in 1817, dealing with a family which traveled up and down the river selling dry goods and groceries to the settlers. It is based on research in diaries, pilots manuals

and biographies of the early Nineteenth Century.

Miss Crawford was born in Little Rock, and attended Randolph-Macon College in Lynchburg, Va. After teaching English for a year at Fairfax Hall, Va., she studied Library Science at the University of Illinois. In 1924 she went to New York as an editorial assistant for the H. W. Wilson Company, library publishers, later becoming an editor. It was while working for the Federal Art Project in charge of research that she came across some manuscripts dealing with boat life on the Ohio river and became interested in the subject.

Lora Crouch, librarian of the Carnegie Library at Mitchell, S.D., gave a talk to the Public Library Round Table of the South Dakota Library Association meeting at Sioux Falls on October 14, 1938 on the subject, "Service to Rural Borrowers from the Standpoint of the City Library." Ellen G. Smith, B.L.S. '02, formerly librarian of the Walla Walla, Washington Public Library but retired last spring, died after an extended illness on August 15, 1938. The following appreciation written by a colleague, Miss

Covington, appeared in the Library Journal of December 15th.

On October 23, memorial services were held honoring the memory of Ellen Garfield Smith, late librarian of the Walla Walla, Washington Public Library. Serving in that office for more than thirty years, she began her work with a collection of 5,000 volumes which increased to 27,000. Miss Smith's devotion to her Library, her staff, and her community while unassumingly quiet was purposeful. On occasions when her viewpoint was sought, one might gather her belief not so much in precept, but in unostentatious diligence and sometimes sacrifice. Her efforts were not confined to library pursuits but were extended where there was need in charitable cultural, and community endeavors. She served on various boards and committees; her activities including the Red Cross, the Archaeological Society, the Art Club, the Symphony Society, Camp Fire Girls, and the Y.W.C.A.

Her professional interests were strong. She was graduated from the University of Illinois Library School in 1902. She had been a member of the American Library Association since 1906 and since 1930 held Life and Contribution memberships. She was active in the Pacific Northwest Library Association and its president from 1929-1931. Miss Smith made herself, through her will, truly one of the "Friends of the Library group" by providing for a trust fund of \$25,000 which, upon the deaths of the beneficiaries who share income from it, is to be paid to the city of Walla Walla to be used for library building. In the meanwhile, at the death of each beneficiary that particular income falls to the Library for book purchases. Miss Smith also remembered the Library of the Whitman College of Walla

Walla.

Her career, marked by personal industry and resulting benefaction, is very significant of an era in professional development. When she came from library school there were possibly six such schools in this country—the oldest about fifteen years of age. They were not only professional schools, but also experiment stations evolving library policies, directing practices, and stimulating initiative. In a life like that of Ellen Garfield Smith one sees the harvest.

Ida Brown Almy (Mrs. Edward John Dobbins), 1893-94, died on January 27, 1939. She was formerly on the Cleveland Public Library staff and was responsible for much of the development of the circulating library at Wm. Taylor Son & Co. Mrs. Dobbins, a native of Newport, R. I., studied at Armour Institute Library School. She then spent seven years in London and Brussels. She was a librarian in Philadelphia three years. Surviving are two sons, Kemper A., an attorney for the Nickel Plate Road, and Edward J., two sisters and a brother.

Lydia Elizabeth Kohn, '04-'05, formerly a specialist on photographs and slides in the Ryerson Library Art Institute, Chicago, writes that she is acting in an advisory capacity for librarians faced with the problem of housing and cataloging collections of this type. She is listed in the A.L.A. Handbook as "Special Organizer of Photograph and Lantern Slide Collections." In the Library Journal for November 15, 1932, she had an interesting article on the subject.
