THE FIRST ALUMNI SCHOLARSHIP

The Executive Board of the Association and the Trustees of the Endowment Fund decided during the winter that the time seemed favorable for granting the first Scholarship from the funds which the Association has been collecting for that purpose since 1925. The principal sum had reached \$6,000 (see report of the Trustees in News Letter No. 17, December, 1932), and interest to the amount of \$300 was available. This was in accordance with the action of the Association at Toronto, which decided that no awards should be made until the principal sum had reached an amount to yield \$200 or more. It was the unanimous opinion of the Executive Board and the Trustees that the amount was now sufficient for the first Scholarship.

Accordingly, Mr. Windsor presented the matter to the Graduate School of the University, recommending that no tuition, incidental and laboratory fees be charged to the holder of the Scholarship, and that the Library School faculty or a committee of that faculty, consider all applications and recommend the best candidate to the Graduate School. The approved plan was then presented to the Board of Trustees of the University and they accepted the gift of the Association.

The Scholarship will operate according to the following plan:

1. The amount of the Scholarship shall be \$300 for the coming year and for succeeding years, with the understanding that the Board of Trustees of the Endowment Fund has authority to reduce this amount, notice of such reduction to be sent to the Library School faculty by January 1st of any year, so as not to delay the advertising and other regulations concerning the award of the Scholarship which will usually be made in March.

2. The money for each Scholarship will be paid to the Comptroller of the University each year before the formal appointment of the candidate and this money shall be paid out to the holder of the Scholarship in accordance with the established practices of the Comptroller's office in the payment of other scholarships.

3. The Scholarship shall be given publicity each year and the candidate shall be selected by a committee of the Library School faculty who will consider all applications and choose the candidate who in their opinion is best qualified to receive the award.

The announcement of the Scholarship was made in the January *Library Journal* and a number of letters were sent out to alumni who might qualify; after the applications were received the faculty committee acted on them and decided that the award for the first year should go to one of our own alumni.

Miss Lucy Brown Foote, head cataloger, Louisiana State University, will be the first recipient of the Katharine L. Sharp Scholarship. Miss Foote received her degree of B.S. from George Peabody College, and her first library degree with the Class of 1930. Her experience and personal traits eminently fit her for the honor bestowed.

Miss Foote's proposed thesis is "A study of the official state publications of Louisiana since 1899"—a project on which she has already begun work and which is in line with the current interests of the Public Documents Committee of the A.L.A.

This first Scholarship will be known as the Katharine L. Sharp Scholarship and is named for the organizer of the School.

## THE ALUMNI ASSOCIATION

Strange as it may seem the Association needs members. Only 28 alumni have paid their dues this year. Do you enjoy the News Letter? If so, remember that it takes money to print it. We must have 100 annual members each year to pay for its publication. We should have more than the minimum of members, however, for the surplus funds in the general treasury are used to make loans to Library School students, who would be unable otherwise to finish the year. Such loans are made only to promising students on the advice of the faculty, and not a year goes by in which several students have not been assisted by this fund. The recipients of these loans have always repaid them promptly and the School feels that this fund is a very worth-while service on the part of the alumni. Annual memberships are only a dollar.

## ADAH PATTON MEMORIAL

Miss Jutton, chairman of the committee, reports that the fund already amounts to seven hundred dollars in cash and, that they are very much pleased with the response to their letter which was sent out to former members of the University Library staff. The replies have been most cordial and many have indicated a desire to make a contribution as soon as economic conditions improve.

## SCHOOL NEWS

*Placement.*—Rarely does a notice of a vacancy come to the School office. People even hesitate to take leaves of absence for further training for fear their positions cannot be held for them. Salaries have dropped in most communities. Statistics compiled the last of December show the following averages for the Class of 1932: M.A. degree, \$1,665; B.S. in L.S. and experience, \$1,200; no experience, \$900. There are 142 alumni desiring positions and 67 who are interested in a change because of the likelihood of a loss of position if further reductions are made in their libraries.

In June we shall graduate 50 students with the B.S. in L.S. degree and 12 with the Master's degree, who will need positions. Altogether twenty men are interested in positions; 10 of them received their degree prior to 1933; 10 are in the present class; 9 will receive the B.S. degree, and 1 the M.A. degree. The Class of 1933 is larger than the above figures indicate, but the other members have positions.

The largest number of the unemployed alumni (including the Class of 1933) are from the following states: Illinois 51, Indiana 17, Iowa 18, Nebraska 12, Wisconsin 9, Missouri 8, Ohio 8, California 8, and Minnesota 7. Twenty-three other states are represented by 1 to 5 former students, now without positions. It is interesting to note that the New

England states and several of the Atlantic states are not included in the list as well as a few of the far Western states.

If you are interested in helping reduce the number of unemployed fellow alumni in your own state, information will be gladly sent to you by Miss Krieg, the Assistant Director of the School.

Knowing that the alumni are always interested in new projects which are being carried on in Library School courses, the following members of the faculty have consented to tell about several of them:

*Miss Boyd:* "Recent graduates of the School who had a part in selecting books for the Browsing Room may be interested to know that this semester the classes in Book Selection are holding a series of book clinics (or something like that!) to try to discover the causes for the unpopularity of some of the books in the collection. Working in groups of seven—or committees as we call them—the students have diagnosed about four hundred books which have not circulated more than once or twice this year. All of the incurables (whether due to internal or external weaknesses) have been ordered back to the stacks; those which promise partial or complete recovery under proper advertising or re-shelving are allowed to remain in the Room, but only on the condition that they immediately show signs of improvement in popularity. You would be surprised to know how many with just this little attention have found delighted readers.

"Even more exciting has been our experience in 'going on the air!' Yes, we have written radio book reviews again this year, but we have broadcast them (that is, a few students have, who possess the proper radio voice—discovered through tests given at the Broadcasting Station.) Our program is called 'Airing New Books' and is to be heard over the University Station, WILL, every Wednesday and Friday morning at 10:45. By the end of the year we will have given fourteen broadcasts. . . ."

*Miss Gramesly:* "The class in Advanced Library Administration has just finished two rather unusual projects. They are folders to be used in the state wide publicity campaign to be carried on by the Illinois Library Association.

"The first leaflet is an appeal to the citizen for his support in keeping the Library running. Much has been made of the increased use of libraries in the present economic conditions; the lack of funds has been touched on lightly. Specific instances as to the increased use among libraries have been given, taken for the most part from library reports.

"The second leaflet has to do with endowments, or gifts and is an appeal to the citizen who wishes to create a public memorial, an investment for the future. The back of this leaflet bears a legal form in case any one wishes to remember his local library. These leaflets are to be distributed broadcast throughout the state."

*Miss Hostetter:* "In the High School Library Administration course, Anna H. Heyer, a member of the class, is preparing with the cooperation of the University Art and Design department, a study of the interior decoration of school libraries. The floor plan and elevations will probably be available for the School Libraries Section Exhibit during the A.L.A. Conference in October."

A new course in Children's Literature to be offered during the second semester of 1933-34 will emphasize the books which best meet the reading interests of children. Miss Hostetter will teach the course.

Miss Florinell Francis, who has been with the School for two years as an instructor of cataloging and classification, is leaving at the end

of the summer session in order to take a similar position on the staff of the Library School of Louisiana State University.

Linda M. Clatworthy, B.L.S. 1900, librarian of Denver University, died of a heart attack on the 23rd of January, 1933, partly as a result of injuries and shock suffered when she was struck by a hit-and-run motorist a few weeks earlier. Miss Clatworthy had been librarian of the University for 12 years. During that time she was chiefly responsible for the library's growth from a small institution to the present beautiful new Mary Reed Library which was dedicated last fall. She was known to thousands of students and alumni who found her extensive knowledge of history and literature helpful to them.

She was born in Dayton, Ohio, and educated at Denison University, Vassar College, Northwestern University, and received her B.L.S. from the University of Illinois Library School in 1900. She also received her Master's degree at Denver University. She was very fond of the outdoors and spent a good deal of time with her brother, Fred A. Clatworthy, a nationally known photographer at Estes Park. She was living with her mother, Mrs. Emma Clatworthy, at 2055 S. Columbine Street, Denver.

Miss Clatworthy was a past president of the Colorado Library Association, organizer of the Dayton Art Museum, member of the National Council of the National Economic Association, and a member of Delta Delta Delta and Pi Gamma Mu sororities.
