"THE RARE BOOK"

Well, in spite of the prognostications of the "doubting Thomases" and "gloomy Jonahs" who said that it couldn't be done, we did it! In other words, we succeeded in surprising Mr. Windsor, and we regard that as *some* accomplishment! Of course, it was quite essential that Mr. Windsor should know that the Library Club was planning a dinner on May 5 in recognition of the completion of twenty-five years of service here, with himself and Mrs. Windsor as honored guests, but aside from that information, the other features of the occasion were a complete surprise—so he says, and he has a habit of speaking the truth.

Probably you will all be interested in learning just how we went about it. As you already know, a Committee of Arrangements was appointed in February, consisting of Emma Jutton, Josie Houchens, Fanny Dunlap, Katherine Doyle, Christopher Faye, Isabelle Grant, Mary Lois Bull, Amelia Krieg, and Bertha Schneider, with Frances Simpson as Chairman. The Committee held four or five meetings at the home of the Chairman, who was directed to conduct all correspondence and decide matters of minor importance.

The first letter sent out by the Chairman went to one hundred and ten of Mr. Windsor's personal and professional friends on February twenty-first, and over ninety replies were received—a very remarkable response, indicating the high esteem in which Mr. Windsor's profession holds him.

The second letter, to fifteen hundred and forty-five alumni and former students of the Library School, was sent on March eighth, and two hundred and fifty-five responses have been received to date. These numbers do not include members of the University Library Staff, the Faculty of the Library School, and students now enrolled in the School, whose letters represented groups and not individuals, as a later statement in this account will show. Because of a threatened deluge of letters, the co-operation of the University, aside from the Library Staff and Library School, was not solicited. In fact, most of the general Faculty knew nothing about the plan.

Quite a number of alumni who are on the staff of the same library, or in adjacent libraries, signed group letters, twelve such letters, bearing seventy-five signatures, having been received. The letters from the University Library Staff were grouped in departments at their own request, and nine such letters, signed by ninety-two persons, are in the volume.

One letter, the one from the Shipping Department, which is manned by our old friend, Ted Wharmby, is so original and characteristic as to deserve special mention.

Thirteen members of the Library School Faculty signed a letter; one emeritus member wrote her own letter.

The letter from Mr. Windsor's graduate seminar class, Library 102b, was signed by ten graduate students, and the one from the Library School, in black-letter Latin by the way, and illuminated, bears fifty-two signatures.

The "Book" itself is a rare one indeed, and is a thing of beauty, thanks to the generous co-operation of our friend, Edward Hertzberg, who asked permission to do the binding as his personal contribution. It measures $8\frac{1}{2}$ by $11\frac{1}{4}$ by 2 inches, making a sizeable volume. The book is bound in blue crushed levant, with five raised bands. The name, Phineas Lawrence Windsor, in gold roman lettering and gold tooling are the only adornments. In place of end papers, Mr. Hertzberg has used gold silk moiré very effectively. A dark blue cloth case, lined with flannel and edged with leather holds the volume, and a bookmark of heavy blue and gold ribbon enables Mr. Windsor to "keep his place" when reading.

The book contains three illustrations, a frontispiece showing the east entrance to the new Library, a really artistic picture; one showing the east facade and part of the north wing, said to be Mr. Windsor's favorite view of the new Library; and a picture of the old Library, familiar to all older alumni.

The Title-page, was done on Whatman paper in black letter and illuminated. This is followed by the Foreword, also done on Whatman paper in black letter with a little illumination, and signed by the members of the Committee under date of April fifth.

The collection of the letters themselves begins with those from the Library Staff "following," as Miss Sharp used to say, "the order of the book," beginning therefore with the Order Department and closing with the letters from the departmental and college librarians. The letters from the Library School Faculty follow. Eighty-four letters with eighty-six signatures from Mr. Windsor's personal and professional friends come next, arranged alphabetically with the exception of the one from Dr. Herbert Putnam, which heads the list. This part of the book includes a letter from the Chicago Library Club, and one from the Lincoln Library at Springfield, Illinois.

By far the larger part of the volume was filled by letters from the alumni and former students. Two hundred and thirty letters reached us in time to be included in the book; the other twenty-five will be bound with other relevant material in an appendix. Ten letters from groups of former students and two letters from members enrolled this year close the volume. In all, the volume contains 337 letters and 550 signatures.

The dinner on May fifth, when the presentation of the volume to Mr. Windsor took place, proved to be such a delightful occasion that it deserves more than passing mention. It was held at The Southern Tea Room on Green Street, Champaign, and was attended by over one hundred and seventy of Mr. Windsor's friends. The local attendance was limited rather closely to library people, with the addition naturally of President and Mrs. Daniels, President-elect and Mrs. Willard, Mrs. Windsor, and Professor

We must not omit Mr. Hertzberg who, with his daughter, drove down that afternoon and deposited the precious volume in the hands of the Chairman. The food was good. The floral decorations were unusually lovely and the company very happy.

The membership in the Association is at a very low ebb, and it is necessary for more alumni to join if the News Letter is to be continued. There

are over 1200 former students of the School in active work, of these nearly two hundred are life members and so contribute only to the Graduate Scholarship Fund. This makes the publication of the News Letter entirely dependent on the \$1.00 annual membership dues. It is not a large sum and it is probable that most of the alumni would join if they just gave it a little thought. Isn't it worth a dollar to keep in touch with your professional Alma Mater? When you go to the A.L.A. dinner reunion of the Library School Alumni, isn't it worth a dollar to feel that you are taking an active interest in the gathering, making a contribution to the Student Loan Fund, to the costs of the News Letter, to the general feeling of unity in the professional group with which you are most closely allied? SCHOOL NEWS

Our estimated enrollment of fifty students for the Summer Session is now complete, but applications continue coming in. Two of the first year courses will be taught by Mr. Charles H. Stone, '16. Mr. Stone has had years of library science teaching experience. He organized the Library School at George Peabody College for Teachers, and continued his teaching at the Woman's College of the University of North Carolina when he left Nashville for Greensboro. Various summers have been spent in teaching at the Columbia School of Library Service.

It seemed opportune to present the new course in Children's literature, offered by Miss Hostetter, for those who have had their training before such a course was included in the curriculum, and who may feel the need for such training in connection with their public library or school library work at the present time.

The advanced work stresses government documents. In connection with the interest aroused in this field through the programs of the A.L.A. Public Documents Committee, we have found a growing desire for training in it. While the courses as outlined seem like a heavy diet of one ingredient, still we feel that librarians might care to specialize this year in this one phase.

Twenty-eight of the students of the class of 1933-34 who are without prospects for positions for the coming year co-operated in issuing, with the consent of the Faculty, a series of printed records of their training and experience. The individual record is on heavy paper of post card size and includes beside the information indicated, a photograph and personal data. The group of records has been sent to large university and public libraries, to state commissions, to state and city supervisors of school libraries, and to a selected group of other institutions where it was considered there might be an interest in Illinois Library School graduates. Each student has a small supply of his own slips for personal applications.

The response from the organizations to which the records were sent as a group, have all been commendatory so far, but as was expected there was no indication of immediate possibilities of placement. It is hoped, however, that with bettering business conditions, the project will really justify itself.

We shall be glad to send "circulating" copies of the records to librarians interested.
