Dear Fellow Alumni:—

I wish each and every one of you could have been with us at Denver when we filled the Venetian Garden at the Shirley-Savoy Hotel, and listened to the songs and applauded the dances of the West as presented by a group of talented high school students in appropriate costumes. Everyone felt that the committee on arrangements deserved a special vote of thanks for such a delightful dinner and program.

DENVER MEETING

The annual dinner and meeting of the University of Illinois Library School Association was held at the Shirley-Savoy Hotel, Thursday, June 27, 1935, with Harriet E. Howe, President, presiding.

The tables were beautifully decorated with columbines (the state flower), miniature covered wagons above which spirals of smoke floated up from outlets in the roofs, and unique place cards in the form of lariat-throwing, chaps-wearing cowboys. Miss Howe expressed for the members present sincere appreciation to the committee on arrangements: Elsie Baechtold, Vera Campbell, Edna Gustafson, Mildred Kenney. Miss Howe told how Miss Campbell made an early

morning trip to her cottage in the mountains for the deep blue columbines. The large orange and blue "Illini Pup" (borrowed by the manager of the hotel from his grandson) added Illinois atmosphere to the decorations, and much merriment as his vociferous bark was used to secure the silence necessary for the business session. During the dinner, the Rebel Rangers, an association of pupils from South High School, Denver, in quaint costumes, sang cowboy songs and danced square dances.

Harriet E. Howe opened the business session with a roll call by classes. Almost all classes were represented, 1929 (18) and 1931 (14) being the banner groups.

Mr. Windsor paid tribute to Miss Margaret A. Gramesly, a much loved member of the faculty who had passed away since the last meeting at Montreal. At Mr. Windsor's suggestion, the association stood in silence one moment in memory of Miss Gramesly. Mr. Windsor then announced the appointment to the faculty of Mr. Guy R. Lyle, formerly librarian of Antioch College, and regretted that Mr. Lyle could not be present to be presented and to receive the welcome of the Association. Beginning with the summer of 1936, Mr. Windsor said, Library School will offer second semester courses for the benefit of those who may not be granted a leave of absence for attendance during the winter semester. It is the expectation of the School to provide enough graduate courses that the M.A. degree may be earned by attending four summer sessions.

Mr. Windsor announced that the Katherine L. Sharp Memorial scholarship had been awarded for 1935-1936 to Miss Mary Silverthorn of the Saginaw, Michigan, Public Library. He spoke of the real pleasure which he and Mrs. Windsor always have in attending the Illinois dinner-meetings.

Miss Frances Simpson spoke briefly, stating that she had timed her trip to California so as to be present at the conference, and expressed her pleasure in seeing so many friends at the dinner.

Miss Krieg presented some interesting statistics about placement work and distribution of 871 graduates according to type of library service and according to geographic location. She urged every graduate of the School with specialized knowledge in any subject, especially in the sciences, to record that fact in the records of the Library School.

The report of the secretary-treasurer was read and accepted. Mr. Trotier read a report of the Adah Patton Memorial Fund.

The officers presented by the nominating committee in their report were unanimously elected: Ola M. Wyeth, President; Charles H. Stone, First Vice-President; Julia Pressey, Second Vice-President; Josie B. Houchens, Secretary-Treasurer; and J. S. Cleavinger, Trustee of Endowment Fund 1935-38.

The meeting was then adjourned with the hope that many graduates of the School would attend the Richmond Conference.

During the year the First National Bank of Urbana paid a dividend of 35% of the deposit which was in the bank when it closed March 4, 1933.

The First National Bank of Champaign paid 30% on the deposit which was there when the bank failed in 1932.

It is probable that more dividends will be received from each bank.

The attention of the Association is called to the fact that only \$103 was received from annual memberships. This seems a very poor showing when we consider the large number of alumni in the active field. Approximately 200 alumni are life members and so pay no annual dues, there are still at least 800 members from whom we might expect some returns.

The costs of the News Letter have not been entirely met for several years and in consequence the frequency of the letters has been reduced.

The cooperation of the State Secretaries in sending reports of alumni gatherings and news of former students in their states has been most helpful and it is hoped that there will be more news sent to the editor all the time.

It is interesting to note that the more recent graduates are beginning to realize that a life membership is a very good investment. It saves all the bother of thinking about annual dues and it ought to give a feeling of satisfaction at having made a contribution to the Scholarship Fund.

EDWARD HERTZBERG

With the death of Edward Hertzberg in Chicago on December 31, 1935, the world lost a master craftsman in the art of fine binding but the alumni of the Library School lost a sincere friend.

When the drive for funds to endow an alumni scholarship was being made several years ago, Mr. Hertzberg heard about it and wrote down to the school saying that he had a deep interest in all former students, many of whom were his friends and patrons and that he would feel it a privilege if he might make a gift to the fund. Shortly after he sent down a check for \$200.00. In 1931 he sent another check for \$100 and in 1933 he supplemented this gift with an additional \$50.00. Thus he was the largest single contributor (\$350.00) to the Endowment Fund.

When the Library School made inspection trips to Chicago, one of the high spots of the trip was the visit to the Monastery Hill Bindery where the students had an opportunity to see the best methods of book binding. On these occasions they also had a chance to see many examples of Mr. Hertzberg's own beautiful bindings and realize through this exhibit and his talk the vast difference between artistic and commercial binding. Then a delicious tea was served and often each member of the class was presented with a souvenir made in the shops.

The Monastery Hill Bindery will be carried on by Mr. Hertzberg's son and daughter who have been brought up in the work and are no doubt known to many alumni.

The Monastery Hill Bindery received its name from the old monastery ruin in Granzow, Germany, where Ernst Hertzberg, founder of the firm, played in his childhood. This monastery had been the home of monks who had

made beautiful bindings for manuscripts and this tradition inspired Ernst Hertzberg to his chosen profession of bookbinding. When Lawrence Hertzberg takes over the management, he will be the third generation of the Hertzberg family to carry on the high ideals of the founder of the firm.

SPECIAL SUBJECT KNOWLEDGE INDEX

I am starting to compile an index to the special subject knowledge of our alumni. We are having an increased number of calls asking for very specific information as to amounts of training in given fields, and it is difficult to find this data without checking lengthy transcripts. Besides, our records often do not include information concerning special study since a student has left here. I should be glad to have notes from those of you who do have special subject equipment, especially from those of you who have not been here recently.

I am also interested in listing all alumni who have had any experience in the teaching of Library Science. If you write me, do tell me the schools or libraries at which the teaching has been done, and describe the work briefly, that is, give me some idea as to the number of classes in the session, the brevity or completeness of the course, and the objective, e.g., for teacher training, for school librarians, for accredited library courses, for orientation.

If there are graduates who are willing to serve in a secretarial capacity in addition to library duties, I should be glad to have them so indexed. A knowledge of stenography and typing is necessary in this case.

Christine Sanders, regional librarian at St. Albans, Vermont, has issued a report on the "Experiment in Regional Library Service, St. Albans, Vermont, September 1934 to September 1935." Having described in a very interesting way the conduct of the experiment and the various handicaps which had to be overcome, she concludes, "It would seem that the regional library idea is the most practical one for the extension of book service to people who live in rural communities, whether the whole county is served, or only part of it or even parts of adjacent counties. But it is a slow process to prove that this is the best way. The more efficient the service, the more speedily, of course, can it be accomplished." She also opened the summer school of the Vermont State Pub-

lic Library department with a very stimulating talk on "The Librarian—her qualifications, education, functions and opportunities." The second week she lectured on problems of general administration.

ALUMNI NEWS

Eliza Jane Skinner, Armour, 1896-'97, reviser-cataloger in charge of bibliographical literature in the Catalogue Division, Library of Congress, died Tuesday, Dec. 31, 1935, at her residence in the Dodge Hotel, Washington, D.C.

Miss Skinner was born at Princeton on July 15, 1859, and was educated at Zurich, Heidelberg and Paris and at the Library School of the Armour Institute of Technology.

Before going to Washington in 1902, she was librarian of the University of West Virginia.

Her work in the Library of Congress during the past thirty-three years was that of aiding in the development, by cataloging and classification, of their extensive bibliographical collection. She was familiar with bibliographies in all fields of knowledge and an expert on books relating to printing, binding, paper, the book industries in general and library administration.

Because of the character of her abilities and services, Miss Skinner was among the first to be exempted by executive order of the President from the provisions of the retirement act prescribing automatic separation from the Library personnel on attainment of retirement age.

Miriam E. Carey, Armour, 1898-'99, is on the faculty of the Minnesota Library School. Her home address is The Marlborough at 9th Street, St. Paul, Minnesota.

Agnes M. Cole, B.L.S. '01, has resigned as head of the Catalog department of the University of California, Berkeley. From 1903-06 Miss Cole was head of the Catalog department of the University of Illinois Library. This year she is taking a real vacation visiting family and friends in the East. Next year she plans to resume work in her old department but only for part time. Her home address is 2414 Telegraph ave., Berkeley.

Clara E. Howard, B.L.S. '01, died on December 7th, 1935, at Emory University, Georgia. She had not been well for some time, but her death was a great shock to her family and friends. Miss Howard had been Dean of the Library School at Emory University since 1930.

Miss Howard's name is also closely associated with the development of High School libraries through her notable work as librarian of the Schenley High School at Pittsburgh from 1916 to 1927. Previous to this she had been a member of the staff of the Carnegie Library, Pittsburgh.

In 1928 she took her Master's Degree at the School of Library Service, Columbia University. For two years she was director of the Library School at the New Jersey College for Women going from there to Emory. She was very active in her professional interests and was a member of many organizations. She was editor of the School Libraries Yearbook for 1931. She was a member of Kappa Kappa Gamma.

Adeline M. Baker, B.L.S. '02, acting head cataloger, University of Nebraska Library.

Ellen Garfield Smith, B.L.S. '02, librarian of Walla Walla, Wash., had her 25th anniversary as librarian celebrated on February 22 by her staff and former members of her staff. The occasion was the annual staff luncheon and the celebration was a spontaneous expression of the high esteem and affection with which Miss Smith has always been held by those who have worked with her. Owing to Miss Smith's popularity in the community and the difficulty of limiting the attendance if all her friends were invited, it was decided to make it a staff party.

Fanny Elliott Miller (Mrs. D. P. Taylor), 1902-'03, died some time ago in California according to word received by the Kappa Alpha Theta Chapter at Illinois. She was for some years librarian of the High School library, National City, California.

Jeannette M. Drake, B.L.S. '03, has resigned her position as librarian of the Pasadena Public Library to take effect January 1, 1936, and will retire from active library work.

Miss Drake is recognized as one of the outstanding librarians on the Pacific coast and has served as president of the California Library Association. She is called by one Pasadena newspaper the "brilliant leader of a great institution of public education." Miss Drake expects to continue making her home in Pasadena.

After going to Pasadena she had much to do with the planning of the new library building there. It was dedicated in 1927. She introduced many innovations in library service which afterwards were adopted by libraries elsewhere. Her outstanding achievements in the library world have been listed in "Who's Who in America."

Helen T. Kennedy, B.L.S. '03, died on July 8th, 1935, at Tujunga near Los Angeles, California.

She was born in Council Bluffs, Iowa, in 1877. She graduated from the University of Illinois Library School in 1903, and held positions in the Public Libraries of Jacksonville, Illinois and Kewanee, Illinois, until 1907, when she was made Instructor in the University of Wisconsin Library School. In 1910 she was invited to become Library Organizer of the Oregon Free Library Commission.

From 1911 to 1931, Miss Kennedy was a member of the Los Angeles Library staff. For a year she conducted the Los Angeles training school, aiding in its development. In 1912 she was made Principal of Branches, but continued to give courses on administration and library buildings in the Training Class. In 1925 she was made second assistant librarian and was busy with the activities of the Central Library.

Miss Althea Warren, City Librarian of Los Angeles writes: "Miss Kennedy's illness which caused her to resign in 1931 brought a loss to the library profession. Her indomitable spirit and fine idealism will long be remembered. Her unselfish devotion to the development of the branch library system in Los Angeles will ever be a part of library history."

Mr. Ainsworth, in *The Los Angeles Times*, wrote: "Miss Helen T. Kennedy is dead. She died as she lived, simply. Few persons even realize that the 'Mother of the branch libraries of Los Angeles' has gone. Yet she probably has done more to bring the joy of books to untold thousands than anyone connected with the library system. She left behind more than one monument. She left a score of them.

"Twenty of the branch libraries of the Los Angeles Public Library system stand as direct proof of her zeal and ability. From 1912 to 1925, when she was head of the branches, she saw to it that these book centers were erected in strategic parts of the far-flung metropolitan area. She brought books to the people, and a new world was opened up to a vast population.

"The branch libraries became individual community centers, the nuclei of a new kind of cultural opportunity. Behind it all was the quiet shadow of Miss Kennedy. She never thrust herself forward. She worked, kept in the background and let the pleasure of others be her reward.

"She was never in robust health. Finally in 1931 her ill health forced her to retire, but she kept up a most active interest in library work. She couldn't keep entirely away from the work and for some months did cataloging in the Santa Fe State Museum Library in New Mexico."

She is survived by her mother, Mary Elizabeth Kennedy, and a brother, The Reverend Melville Kennedy of Champaign, Illinois.

Ralph M. Whiting, 1923-'24, died Sunday, February 10th, 1935 in Los Angeles, California. Death was due to pulmonary embolism and lobar pneumonia, a condition which was aggravated by an old war injury.

Mr. Whiting was born in Whitman, Massachusetts, February 7, 1893. He was educated in the public schools of Brocton, graduating from the High School in 1911. Soon afterward he went to work for the General Electric company in Lynn.

On June 14, 1917, he enlisted at Alliston as corporal in the 101st Infantry, Field Signal Corps, of the 26th Division. In September he went overseas with that unit and was cited for gallant conduct at Siecheprey on April 20, 1918. The following June 19th he was severely wounded at Beaumont and he never fully regained his health.

At the close of the World War, Mr. Whiting attended Columbia University and the University of Illinois, receiving his degree of Bachelor of Science in Education in 1925 at the latter institution. For two years he served as assistant in the Business branch of the Minneapolis Public Library, after which he became assistant librarian of the municipal Reference Library at Los Angeles, California. Because of failing health in the summer of 1931, he asked to be transferred to the Catalog Department, but his health forced him to resign March, 1932.

When he first came to California he was greatly interested in library activities and organizations until his health began to interfere.

He was a member of the A.L.A. until 1933. He was secretary and treasurer of the Southern Californian Chapter of the Special Libraries Association 1928-29, and he was president of same 1929-30.

Mentally, he was very active; he read incessantly. Besides following cer-

tain lectures and programs on the radio, he studied astronomy and microscopy as a hobby. With the development of economic and political changes, he read and studied every change from every angle possible and became so well informed that men from all walks of life, both friends and strangers, came to him for advice and information.

Besides his parents, he leaves his wife, Mrs. Ada (Nelson) Whiting, B.L.S. '25, librarian of the Hyde Park Branch of the Los Angeles Public Library, whom he married August 4, 1925; also a sister, Miss Esther M. Whiting, a teacher in Brocton, Mass.

Phyllis Crawford Scott, B.L.S. '24, has resigned her position with the H. W. Wilson company to supervise a WPA project in New York City. The project is to furnish a pictorial index to American design, beginning with costume and architecture.

When a swarm of locusts appear they are exultant over the feast of the moment, forgetting the damage to their crops. There are flying ants which, at one season, comes swarming out of their holes at twilight every day. Crowds of natives squat around the holes catching the ants as they appear and popping them into their mouths alive."

The women work in the fields, but the men are not idle. They build the mud huts, they hunt, they make the family money. Not every family has money, but more and more is coming into circulation, and in native markets exchange is on a money basis as well as in kind. Many native men work for the missions, for the state on road work, for the plantations. All transportation is done by man power either by crude carts pushed by men or bamboo poles laid across muscular shoulders. There was much more of equal interest. Her address is Care A.P.C.
