The state chairmen of the Alumni Association are hereby asked to continue their work as outlined last year by our ex-President-Bertha Schneider. The Secretary-Treasurer reminds us that the news letters are not paying for themselves. Therefore I am hoping that the state secretaries will be busily engaged in getting in new annual and life memberships to report at the June business meeting. The annual dinner and meeting will be held Thursday evening June 27th at the Shirley-Savoy Hotel. Mildred A. Kenney of the Denver Public Library is Chairman of the committee for the reunion. Howe, President MONTREAL MEETING The annual dinner and meeting of the Association was held at the Windsor Hotel on June 28, 1934. There were one hundred and three present. At the close of the dinner, Bertha Schneider, President, called the roll by classes; 1930 was the banner class with ten members present. The report of the Secretary-Treasurer was read and accepted. Mr. Cleavinger gave the report of the Trustees of the Endowment Fund. A report of the Adah Patton Memorial Fund Board was read by Miss Bond. Miss Schneider said that the Executive Board had been working on three lines of endeavor during the year. (1) For a close unity among the alumni by means of reunions, such as breakfasts or dinners held at state meetings and in cities where a number of alumni were gathered permanently. (2) The appointment of a secretary for each state to arrange for meetings, collect dues, and news items and to send such collections to the Secretary-Treasurer who is also the editor of the News Letter. (3) An effort to increase the annual membership of the Association especially by urging the more recent graduates to join. She reported that the reunions had been unusually successful and hoped that they would be continued as a permanent custom. Miss Lucy Foote the recipient of the Katherine L. Sharp Scholarship

for 1933, the first scholarship granted from the Alumni Endowment Fund was then presented and spoke for a few minutes. Miss Krieg gave a few minutes talk on the placement situation and presented various statistics which were of interest. Miss Phelps spoke of the various changes in the Library School curriculum. Miss Boyd gave a graphic account of the dinner which had been given to Mr. Windsor on the occasion of his 25th anniversary as librarian and director of the School. Mr. Cleavinger spoke of the loyalty and affection of the alumni for Mr. Windsor and moved that the Association appoint a committee to confer with the University authorities with regard to naming the Library the Windsor Library. Mr. Windsor hastened to protest because he said there was a University rule of long standing which forbade the naming of any building after a living person and he was very much alive. Mr. Cleavinger protested that he wished the Association to go on record as desiring such an action and the motion was passed. Mr. Trotier was then presented as the new Head of the Catalog Department of the University and he spoke for a few minutes on his appreciation of the cordiality he had experienced since his appointment.

Mr. Windsor devoted most of his talk to expressing his appreciation of the anniversary dinner and of the beautifully bound book of letters which was presented to him on that occasion. He had the book with him

and an opportunity was given for its examination.

The Nominating Committee then presented the following slate which was unanimously elected: Harriet E. Howe, President; Arthur Smith, 1st Vice-President; Floy Carroll, 2nd Vice-President; Josie B. Houchens, Secretary-Treasurer; Louise B. Krause, Trustee for the Endowment Fund, 1934.

A telegram of greeting was sent to Miss Simpson expressing the regret

of the Association that she could not be present.

Miss Howe was then presented as the new President and she responded with a very cordial invitation to attend the next reunion which would be held at Denver.

THE ALUMNI ASSOCIATION

THE ADAH PATTON MEMORIAL FUND

As a good many of the Alumni know, this memorial to Miss Patton was started in 1932 under the auspices of the Library Club of the University Library to establish a fund for publishing in the general field of library science but especially in cataloging, classification and bibliography.

In spite of the adverse economic conditions the fund has been growing steadily and at the last meeting of the Library Club, the Memorial Fund

Board reported that \$1,521.38 had been received in gifts.

Our Library School Alumni could undoubtedly provide much valuable professional literature that would be worthy of publication, indeed the School has several items on hand already if funds could only be found for their publication. To this end, many Alumni may feel that they would like to contribute, even though they did not personally know Miss Patton. MARGARET AMIDON GRAMESLY

Margaret Amidon Gramesly, B.L.S. '04, who has been a member of the faculty of the University of Illinois Library School for the past twelve years, died suddenly Sunday, August 12, at her home in Urbana. She had not been well for some time, but with the courage so characteristic of her, she made light of her condition and insisted on fulfilling her contract to teach in the Summer Session at Baton Rouge. As her death came only a week after her return, her friends now realize that these last weeks must have been a terrific ordeal and only her will power carried her through.

Miss Gramesly was born in Charleston, Illinois, where she attended the public schools. After attending Illinois State Normal University at Charleston, she entered the University of Illinois and was granted the B.L.S. degree in 1904. Between that time and 1922 when she returned to the University of Illinois Library School as instructor in library administration, she served in many capacities in the public libraries of Illinois and Tennessee, and in the state commissions of three states: Missouri,

She was Children's Librarian in the Jacksonville, Illinois Public Library from 1904 to 1905; Branch Librarian, Cossitt Library, Memphis, Tennessee, 1905-06; Manager, Traveling Libraries, Missouri Library Commission, 1906-12; First Assistant, Traveling Library Department, Ohio Library Commission, 1912-15; Librarian, Charleston, Illinois, Public Li-

brary, 1915-21; Organizer, Iowa Library Commission, 1921-22.

Besides teaching at the University of Illinois, Miss Gramesly taught during the summers of 1927-31 at George Peabody College for Teachers. and during the summer of 1934 at Louisiana State University School for Library Service. She was a popular teacher and brought to her students a broad perspective of the library field as well as an appreciation of all phases of library work. Her students and her many friends will always remember her for her gay sense of humor, her vivacity, and her personal interest in them.

SALARY STATISTICS FOR THE UNIVERSITY OF ILLINOIS LIBRARY SCHOOL ALUMNI

For a number of years the University of Illinois Library School has collected, from its former students, statistics on salaries and positions. These have been published about every three years in the News Letter

and present an interesting picture of salary trends.

The last tables in 1930 represent probably the peak in library salaries. Before that the trend was slowly up and since then rather rapidly down. It is impossible to make these tables show a true picture of the whole salary situation for the figures are taken only from blanks returned, and many Alumni did not reply and some who replied omitted the salary. Out of 1127 in active work, there were 834 replies which could be used. As usual, some of the Alumni whose salaries fall in the higher brackets did not return their blanks.

The peak first year registration of the Library School was in 1930 with 152 students, and in 1931 with 134 students. Since then the registration has been held down to about 60 in an effort to relieve the placement problem. This has meant that applicants were rejected each year, and not that there has been any appreciable decrease in the numbers

seeking to enter the profession.

Table 1 gives the average salaries for men and women who have taken the one and two years course since 1917. This shows clearly the rise to 1930 and the decline since the depression. Figures in parenthesis give the number of replies.

Table 2 will show how many people are receiving the same salaries, and the spread of the salaries over the entire group. In 1927 there were 46 people reporting who received \$3,000 and over; in 1930, there were 76; whereas only 38 reported that salary in 1935. In the middle group the

figures for 1927 showed 204 receiving \$2,000 to \$2,900; in 1930, this number showed a slight increase to 234; in 1935, it has fallen to 177. For 1923, 1927, and 1930 the largest group receiving the same salary was the \$1,800 group, but the 1935 statistics show that this figure has fallen to \$1,500 or the level in 1920.

The salaries for women with the Master's degree still show an advantage over the first year group; however, the two year group has suffered severely. Where the 1930 figures (191 reporting) show that the largest number in this group receive \$2,500 and over, the 1935 figures (193 reporting) show that the salaries received by the largest number of two year women lie between \$2,500 and \$1,800 with a disturbingly large group receiving less than \$1,800.

The salaries for women with only one year of training show a similar decline. In 1930 the median salary for the group was \$1,800, and in 1935 it was \$1,500. When we consider that this group is composed of college graduates, a supposedly picked group (if the Library School requirements mean anything) that they have had one year of additional college work (which in almost any other subject would entitle them to a Master's degree), it seems that the rewards of library work are too meager to continue to attract the most desirable type of college graduate.

Salaries for men also show a decided decline, but this is partly due to the increase in the number of young men who have entered the profession in the last five years. In 1930, only 41 reported; in 1935 the number was 71, almost double. Even with this increase in numbers, the salary figures are decidedly encouraging as compared to those for women. (See Table 1.)

Table 3 is based on a classification by types of position and by types of libraries. The distribution between university and college libraries, and public libraries is in favor of the former. Cataloging still claims about 25% of the number reporting. School library work shows an increase from 70 in 1930 to 119 in 1935. Special libraries have attracted 59 in 1935 as against 24 in 1930.

University and college salaries are still a little better than public library salaries for similar positions. Catalogers' salaries make a good comparative showing. Positions under teaching and related work continue to offer better average salaries than the more technical library positions.

Table 4 appears for the first and we hope the last time. It is cheering to note that 56 people were fortunate in receiving no cut in salary and that 31 were actually handed a gift from the gods—an increase. The fact that in some cases cuts have been restored is a hopeful sign. The other figures speak for themselves.

The compilation is based only on the blanks which gave specific information on the subject. Some were too vague to be included.

Unemployment—The known list of unemployed Alumni now numbers 110 of these a number had temporary employment either for all or part of the year largely through substituting during the leave of absence of some former student or on some FERA or CWA projects.

However 70 either had no temporary employment or did not report any. Eleven of these belonged in the classes from 1902-18, 25 in classes from 1919-30, and 34 from 1931-34. The graduating class in June has 55 members. Of these, 33 are as yet unplaced though some have established contacts which may lead to positions. Perhaps it is a sign that optimism is really growing that 132 former students have written in this spring desiring a change of place.

In 1930 it seemed that when a person had been out of Library School for from 10 to 15 years there might be a reasonable expectation of a salary of at least \$2,500 as that figure had held since 1923. This figure shows a drop for 1935, it will be interesting to see if it is restored by the date of the next tabulation.

China makes one calm and take life easily, nothing can be done in a hurry, already my patience has come to the fore and all nervousness has dropped away. The director, Mr. Seng, and Mrs. Seng, have been most cordial and solicitous for my comfort."

Later she writes that she is settled in her own home, with a house boy named Teh Pao to look after her comfort. It was all delicious, there was a tiny cup of Chinese wine at each plate, which they drank to various guests. After the feast they broke up, as it is the custom to do the visiting before and during the meal.

Mission Lubondai (Tshimbula) Congo Belge via Lobita, Africa. She has written several very interesting letters relating her experiences in making the long trip via auto from Matada to the interior. While everything was interesting and often picturesque, she was disappointed not to see tigers and crocodiles at every turn. For nine days they drove over every sort of country from mountains to vast stretches of sand, and it was more often cold than hot. The native villages were especially fascinating, some just grass huts, others of clay with whitewashed walls and crude drawings on them. The natives were curious but friendly. Lubondai is a lovely spot located in a plateau 3000 feet high; there are five residences, two guest houses, a church, the hospital, and the buildings of the native boys and girls homes, all of the houses being built of brick made by the industrial workers of the school.

A later letter tells of a vacation she took with two other teachers in a Chevrolet truck. "After much discussion as to whether three girls should go off alone, we jogged away and had a better time than has been had in many a Rolls-Royce. We must have made a ridiculous picture tho, with tropical tin trunks, chop baskets, sun helmets, and the native boy. Driving in the Congo presents difficulties, torrential rains may wash away parts of the road, or deep sand may be encountered. Native villages swarm with humans, and animals of all kinds, especially starving dogs. A Congo ferry is a plank platform stretched out on native pirogues or canoes. You get onto it across two boards about a foot wide. It's quite a trick to center

the wheels and once on not to plunge off the other end."

She spent Christmas at Bibango where another native school is located. This is a beautifully located station, "it teeters dizzily on the crest of a peak, the houses are built with their backyards in neighborly proximity, and their faces out in the atmosphere; the view is made up of peaks and abruptly rolling hills which are carpeted with lush green grass, but the narrow valleys between are thickly forested. Living in sight of that

panorama for two weeks was worth giving up many of the joys of civilization."
