Dear Fellow Alumni:

The Executive Committee of the Illinois Library School Association

extends to each one of you its greetings and best wishes.

We wish that it had been possible for all of the 1200 former students of the School in active work to have been present at the reunion in Chicago in October during the meeting of the American Library Association. Pride in our organization which numbers among its members many in the front ranks of library endeavor who are serving their communities gallantly and unselfishly, and the spirit of good fellowship in a group whose members have the same heritage of professional training and ideals, prompt us to suggest that we establish a "new loyalty" for ourselves or reaffirm an "old loyalty" that has been allowed to fade with disuse.

year!

ALUMNI ASSOCIATION ANNUAL MEETING AND REUNION

The annual meeting of the Association was held in Chicago, October 18, at the International House, University of Chicago. The dinner was attended by 224 former students of the School and was the largest gathering the Association has ever held. The dinner was in charge of Adele Whitney, Dorothy Martin, and Mary Lou Nichols of the University of Chicago Libraries and was most successfully managed.

After the dinner Jerome K. Wilcox, the President, talked for a few minutes on the aims and hopes of the Association and then called for a roll by classes. The report of the Secretary-Treasurer was read and accepted. Ethel Bond then told of the Adah Patton Memorial fund. The Nominating Committee composed of Miss Simpson, H. Einae Mose, and Anita Hostetter then presented their report which was unanimously accepted, electing Bertha M. Schneider, President. This concluded the

formal business meeting.

The president then called on Mr. Windsor, who spoke of the unusual conditions which had faced the University of Illinois and the effort which had been made to adjust its reduced income so as to cause the least unemployment and injury to its work. He said he believed in selfexamination and would welcome the scrutiny of the Library School by University authorities feeling confident that the existence of the School was amply justified by the fine professional standing of the alumni, and by the loyalty of its former students which has been evidenced in many ways, and more recently by the fact that they have raised an endowment fund for an annual scholarship. The aim of the faculty has always been to keep the course alive and in line with new trends, and the curriculum of the first year has been worked out from two points of view, first to prepare for beginning work in libraries and second to give sufficient foundation of professional knowledge and professional attitude to prepare a student for continued progress in the profession either through active work or by continued formal study.

Miss Simpson was called on amid much applause and amused every one by saying that although she had no formal duties at present, she was so busy catching up with all the things she had always wanted to do, but never had the time for, that now she had time for nothing else and was busier than she had ever been. Miss Ahern expressed her pleasure at being one of the Illinois Alumni and said that she had great pride in the fine strong body of alumni which had grown out of the spirit of the School. Mr. Utley, the only honorary member of the Association, spoke with appreciation of his long acquaintance with the School and of his pleasure at having a number of its alumni on his staff. Mr. J. Christian Bay, Librarian of John Crerar, and a guest of the Association talked a few minutes on the pleasure he felt in looking back on his library experience and recalling the Illinois graduates he had known in the Library of Congress and in John Crerar. He urged the recent gradu-

ates to remember that youth was the period in which they should accumulate those aspirations with which they would have to live and that part of the pleasure of greying hair was to see those aspirations fulfilled.

ADAH PATTON MEMORIAL

Generous gifts from the Patton family have made possible the permanent organization of the Adah Patton Memorial Fund Board, much sooner than could have been done otherwise. The Board consists of the following members: P. L. Windsor, Ethel Bond, Frances Simpson, A. H. Trotier, Eleanor M. Robertson. The Fund, at the present time, amounts to \$1,310. It is the desire of the Board to increase this to at least \$3,000 within the next two or three years.

Minnie Earl Sears, B.L.S. '00, died in New York on November 28, 1933. She is widely known to the library world for her work as an editor of reference books. The first twenty years of her career were devoted to the scholarly study and practice of cataloging, her first position was in the catalog department of the University of Illinois; after that she was head cataloger in Bryn Mawr College Library, and then in the University of Minnesota Library, leaving there to become first assistant in the Reference-Catalog section of the New York Public Library. In 1920 she joined the editorial staff of the H. W. Wilson company, entering on work which enabled libraries throughout the country to enjoy the fruit of her wide knowledge and experience. From 1927 to 1931 she taught advanced cataloging in the Columbia University School for Library Service, organizing one of the first thoroughly graduate courses in this subject. She found time outside of her editorial work to engage in some cataloging activities for the A.L.A. and other library groups.

Twenty published volumes bear her name, those which are more familiar to the whole library world are the "List of Subject Headings for Small Libraries," "The Song Index," "The Essay Index," "The Chil-

dren's Catalog" and the "Standard Catalog for Public Libraries."

Adaline M. Baker, B.L.S. '02, has a temporary position in the catalog

department of the Public Library, Evanston, Illinois.

Ruth Abbott, B.L.S. '03, died at Presbyterian Hospital, October 28, 1933. She had been on the staff of the University of Chicago Library since her graduation, and since 1916 had been Librarian of the School of Education. She was widely known in the library world for her fine professional work and her generous, attractive personality had won for her many friends.

Margaret A. Gramesly, B.L.S. '04, will teach at the Louisiana State University School of Library Science, Baton Rouge, Louisiana, this sum-

mer.

Alice Louise Wing, B.L.S. '04, is acting librarian of the Public Library

'17, cataloger in the department of texts and libraries of the Public Schools at San Francisco, died on May 16, 1933, after a brief illness. She had gone to Berkeley for a visit with her parents before starting on her summer vacation when she was suddenly taken ill and died from heart trouble. She was a graduate of the University of California in 1915; first served in Stanford University Library, then later in the Stanford Hospital Library at San Francisco. She was librarian of the City of Richmond for a while, then for two years was librarian of Eleventh Naval district in San Diego.
